A BYLAW RESPECTING DOGS AT BEAVER CREEK CONSERVATION AREA.

Short Title

1. This bylaw may be cited as the "Dog Bylaw".

## **INTERPRETATION**

2. In this bylaw:

"Authority"

(a) "Authority" means the Meewasin Valley Authority;

"Peace Officer"

(b) "Peace Officer" means a member of the Police Department of the Rural Municipality of Corman Park, a member of the Police Department of the City of Saskatoon or a member of the Royal Canadian Mounted Police.

## STATEMENT OF PURPOSE

It is unlawful for a person who owns, has an interest in, harbors or has charge, care, control, custody or possession of a dog, to permit the dog to be in or upon the area known as Beaver Creek Conservation Area and described in Schedule "A" of <a href="#">The Meewasin Valley Authority Act</a>, unless he has written consent of the Chief Executive Officer of Meewasin Valley Authority or has a working seeing-eye dog.

#### **APPLICATION**

This bylaw shall, upon coming into force, apply to Beaver Creek Conservation Area as described in Schedule A of this bylaw.

## **PENALTIES**

A person who contravenes any of the provisions of this bylaw shall be guilty of an offence and, upon conviction, shall be liable to a minimum fine of \$100.

A violator of this bylaw, upon being served with a Notice of Violation may, within 10 days, voluntarily pay the penalty to the Rural Municipality of Corman Park or Meewasin Valley Authority, and upon payment as so provided, that person shall not be liable to prosecution of the offence.

#### **ENFORCEMENT**

Any peace officer may enforce this bylaw.
