# River Heights Trail & Site Enhancements Engagement and Board Resolution

February 18, 2021

The Saskatoon and area community is invited to learn more about planned Meewasin Trail and site enhancements in the River Heights area and to provide feedback.

At the Meewasin Board meeting on February 5, 2021 the board passed a resolution in regards to trail enhancements as follows:

To accept the application by Meewasin to construct trail and site enhancements at River Heights in Meewasin Park be approved subject to final details on:

- Planting plan
- Lighting
- Stairs
- · Reconcile design with existing cross-country ski trails
- Biomass replacement
- Re-engage the community on detailed design, including a safety audit in the spring/summer
- Explore options for traffic calming at pedestrian crossings and vehicular access to upper Meewasin Park with the City of Saskatoon
- Final approval of detailed design from the City of Saskatoon

The area, adjacent to the River Heights neighbourhood, starts at Capilano Drive at the west end and continues east to Spadina Crescent, through Meewasin Park. The project includes the installation of 1.4 kilometers of new primary trail in sections without a formal trail connection, upgrades to existing trail sections, and enhancements to adjacent areas.

Engagement sessions on project design elements will be held virtually on:

Thursday March 11, 2021 from 6-8 pm Saturday March 13, 2021 from 1-3 pm

All participants are asked to pre-register by emailing meewasin@meewasin.com by March 11 at 4:00 pm. Questions can be submitted to this same address.

Our goal is to have the designs ready to take advantage of potential funding to support construction. Meewasin is a charitable organization that relies on fundraising to support trail enhancements. Construction timelines are often dictated by our ability to raise funds.


#### **About Meewasin Valley Authority**
