Meewasin Begins Master Planning Process at Southern Natural Area

July 14, 2022

In 1997 Meewasin purchased a property south of Saskatoon which included a 25 year lease to the Leisureland Co-op, ending December 31, 2022. The area consists of a 22.66 Ha parcel, plus a portion of adjacent Yorath Island, both of which are within the RM of Corman Park. The site has been used primarily for recreation since as early as 1915, with camping on the site but it was never designed for permanent residency. Meewasin expects to return the site back to a natural space. The main site is characterized by significant stands of predominantly native trees and shrubs, with some grassland areas that were opened up in the past for recreational use. A small network of trails weave through the west end of the site as well. The majority of the site sits below the 1:500 flood level.

Meewasin has initiated a master planning process that will provide a basis for future decision making, including plans for development and operations. It is anticipated that the site will remain predominantly in a natural state, with potential opportunities for low impact passive recreation. With future Meewasin Trail development expected, this location could extend the southern trail terminus on the west side of the river.

Meewasin is moving through its process for master planning at the site. This process is comprehensive and takes time to complete. There will be opportunities for public engagement on what the future site use will be and we are excited to hear from the community on what they would like to see. A baseline inventory has already been completed with significant ecological assets being identified including habitat for many flora and fauna including some species at risk.

CEO Andrea Lafond spoke to the end of the lease, "This area is so beautiful and we can understand why it is disappointing for residents whose time is coming to an end. When selling the area to Meewasin, the previous owner had a vision that the space could serve the broader public and be returned to a more natural space".

There are significant safety concerns with the site currently including including no potable water, risk of flooding and fire, trespassers and illegal dumping.
