Partners from Across North America come together in Saskatoon for Grassland Health

October 26, 2022

In partnership with other partner groups from British Columbia, Alberta, Saskatchewan, Manitoba and the United States, Meewasin hosted Canada's first Prescribed Fire Training Exchange (TREX). In total, 40 participants were engaged from 10 organizations. The key focus of a TREX is to promote effective cooperative prescribed burning—helping diverse partners leverage skills, resources and staff in ways that maximize opportunities for reaching ecological and community safety goals. Four of the five planned days had favourable conditions that saw a total of over 240 acres burned at the following locations:

- Northeast Swale
- Beaver Creek Conservation Area
- Wanuskewin
- St. Denis National Wildlife Area
- Kernan Prairie Research Farm

Successful prescribed fires at these areas contributes to the ecological goals of reactivating sand dunes, prairie restoration, reducing litter and fuel load, and protecting habitat for endangered species.

"The TREX event will help to more successfully use prescribed fire for years to come. The training and networking completed this week will serve those who participated and the environment as we all work to halt and reverse the loss of important biodiversity and specifically those of native prairie grassland," explains Resource Management Officer, Renny Grilz.

"Meewasin is sincerely thankful to the partners in TREX, and the resources from the Weston Family Foundation-Prairie Grassland Initiative, together we all play a role in prairie restoration. This work is also integral in supporting Meewasin's goal to annually enhance and/or restore no less than 25% of property in the defined corridor by 2024. Meewasin is committed through

partnership to enhancing life on land and contributing to a sustainable city." States CEO, Andrea Lafond.
